VENDOR APPLICATION

The Bell Cow Boil will be held on **Friday, May 3 from 5:00-8:00 P.M.** at the South pavilion of Tilghman Park in Chandler, OK. Booth space is available for businesses and organizations. The Chamber has the right to approve all vendor requests. **FOR THIS EVENT, WE WILL NOT BE ACCEPTING FOOD VENDORS.**

The following guidelines apply:

1. Craft/vendor booth rental is \$50 for each 12 x 12 space. This comes with **one all you can eat meal ticket.**
2. It is the vendor's responsibility to have the appropriate licensing and to pay sales tax. **When the event is over, return the enclosed Oklahoma Sales tax forms and payment to the Chandler Area Chamber booth.**
3. Setup time is **Friday, May 3 by 4:00.** All vehicles must be parked in the area west of the pavilion.
4. The Chamber will choose the setup location.
5. Vendors selling alcoholic beverages must have a City of Chandler Special Event Permit as well as state license. Additionally, those individuals desiring to serve alcohol for consumption on public property are required to go before the Chandler City Council prior to event for permission to do so. An application may be obtained at Chandler City Hall. The City Council meets on the second Tuesday of each month at 5:30 p.m. It is the responsibility of applicants to make a timely request to the City Council.

We will be having a silent auction at this event if you would like to donate an item.

A refund, less a \$10 per vendor processing fee, will be given to vendors if notification of cancellation is received 14 days prior to the event. No refund will be given due to a rain out of the event.
